It will be possible to hold further consultations as needed in future;</li> <li>The board noted the potential legislative approach and agreed it would be helpful to consolidate the accounts of the two OFSOs if practicable.</li> <li>While implementation is desirable and should be encouraged to be in place for 1 January 2019, the board agreed this was not essential for 1 Jan 2019.</li> </ul>

	The board received completed questionnaires from two board members and all staff members, reviewed the report on conflicts of interest and noted the one actively managed potential conflict.
